DESCRIPTION OF ARTICLE(S):

One platinum "Tiffany & Co", "130th Anniversary Collection" diamond ring. The design consists of a cast and hand assembled ring centering one (1) round brilliant cut diamond mounted in a six prong "Tiffany" crown. The "Tiffany" crown is embellished with forty (40) round cut diamonds mounted pave' style. The knife edge style shank contains ninety-eight (98) round cut diamonds mounted pave' style. The shank measures 2.20 mm wide at the shoulders tapering to 1.77 mm wide at the base. The ring is finished with a high polish. The total gross weight of the ring is 4.1 grams. Stamped Tiffany & Co. #37485144, D1.66 cts. Only one hundred and thirty limited edition rings were made for the "130th Anniversary Collection". Tiffany Grading Report #37485144 / Q12010021.
