DESCRIPTION OF ARTICLE(S):

One 18kt yellow gold, fancy pink sapphire and diamond ring. The design consists of a cast and hand assembled ring centering one (1) oval shaped pink sapphire mounted in a double four prong frame. The center stone is surrounded by ten (10) round cut diamonds mounted in prongs and two (2) horizontally set baguette cut diamonds mounted in bars. The top of the ring measures 18.00 mm long x 17.20 mm wide. The shank measures 1.80 mm wide. The ring is finished with a high polish. The total gross weight of the ring is 6.7 grams.
